#### **OUR MISSION**

The National Art Education Foundation (NAEF) invests in innovative initiatives to support instructional practice, research, and leadership in visual arts education.

#### **OUR VISION**

As an independent, philanthropic organization, NAEF supports a wide variety of professional activities, including support for visual art educators to participate in professional development programs; the promotion of visual arts education as an integral part of the curriculum; the exploration of new models of visual arts instruction; the promotion of the teaching of art through activities related to the instructional process, curriculum, student learning, student assessment, management, or discipline; the purchase of equipment and/or instructional resources; and conducting research in visual arts education. NAEF is a sister organization to the National Art Education Association (NAEA) and provides support for a variety of visual arts education programs for the Association and its members.

NAEF has supported over 300 projects since its inception in 1985.

#### **HOW IS THE MONEY USED?**

Approximately \$50,000 is allocated to NAEF grant recipients annually in five grant categories. Requests total approximately \$200,000 per year.

NAEA supports NAEA Leadership Initiatives including the 1st National Leadership Conference, the NAEA School for Art Leaders, the NAEA Research Commission, and the NAEA Research Pre-Conference, totaling over \$400,000 since March 2011.

NAEF grants are awarded to NAEA members, including student and retired members, state/province associations and recognized affiliates.

NAEF is a 501(c)3 non-profit organization: All donations are tax-deductible.

100% of gifts are allocated to Grants and Leadership Initiatives. 100% of NAEF Trustees donate to NAEF.
